## **VOLUNTEER CONTRACT FLORIDA YORKIE RESCUE (FYR)**

This is to certify that I, \_\_\_\_\_; a volunteer with Florida Yorkie Rescue, Inc., understand that:

I am acting as a temporary custodian of any and all dogs (in my care) that are the sole custody of FYR while performing duties as a transporter, home checker, or foster parent.

FYR reserves the right to reclaim the dog /dogs at any time and I will return the dog immediately upon said request.

I will never abandon the dog; give, sell, or transfer ownership of the dog to another person, relative, rescue group, humane association, shelter or pound, pet store, or any medical or experimental laboratory or similar organization.

I do not have the right or authority to keep the dog in other homes or with other individuals.

I am to contact FYR immediately if I can no longer care for the dog.

I agree to indemnity and hold harmless FYR against any damages incurred as a result of my volunteer duties, including but not limited to property damage, accident, personal injury or death.

If I made any misrepresentation about myself or home environment, or if I don't abide by the terms and conditions of this contract and my failure to do so in any way jeopardizes or adversely affects the health and welfare of the dog, FYR can terminate this contract and reclaim the dog without notice, irrespective of any expenditures that I have made, and FYR may pursue legal means to do so.

FYR does not make any guarantees as to the health, temperament, mental disposition, or training of the dog.

I fully and completely release FYR, its Founder, Board of Directors, and volunteers, from any and all claims and liability, including, but not limited to: any defects or illnesses the dog may have or develop, and for any injury or damage to persons, property, or other household pets, which may be caused by the dog. This includes any and all actions and causes of actions, lawsuits, debts, dues, accounts, bonds, covenants, agreements, judgments, claims, and demands whatsoever arising from or relating to my volunteer duties, adoption, placement, and/or possession of the dog.

I understand that I hold a volunteer position and am not covered by any insurance policies held by FYR.

I am performing volunteer duties on my own volition and under the complete direction/instruction of FYR.

**I am not an FYR agent or representative and am not authorized to act on behalf of FYR.**

**I have read the job descriptions for Transporter, Home Visits, and Foster Parent and I agree to follow the directives as such.**
